- 3) 3rd priority will be given to Non IOCL and accordingly seats will be allotted through Draw of Lots.

CATEGORY II:

- 2) Admission will be through Draw of Lots if number of applicants are more than vacancy.

- 4) Without requisite documents, form will be rejected.
